Method of Electronic Disclosure. All disclosures that we provide to you electronically will be provided directly to any verified email address you provide us in your Curae Credit Card Account Center at https://patient.curae.com/my-account Account Center. You must have a valid email address or mobile device to receive Disclosures electronically. Note: All billing statements for which you receive an electronic notification are payable by the payment due date. You are responsible for making required payments on time, whether or not you view your electronic notification or view your statement in the Curae Credit Card Account Center.

Paper Copies. You may request a paper copy of any Disclosure by calling the number on the back of your card to request a copy via mail. You may also print a copy of any Disclosure emailed to you or provided to you in your Curae Credit Card Account Center.

Updating Your Contact Information. We reserve the right, at our sole discretion, to modify or discontinue your election to receive Disclosures electronically, or to terminate or change the terms and conditions on which we provide Disclosures electronically. We will provide you with notice of any such termination or change as required by law.
